EURES Targeted Mobility Scheme (TMS) Sweden

Applications sent after the job interview are not eligible.

Processing can take up to four weeks, so please submit your complete application as soon as possible.

To be sent before the job interview, preferably 1 week in advance:

	2. ID.pdf Copy of passport or national identity card (both sides)		
	3. CV.pdf Updated CV		
	4. Job vacancy.pdf Copy of job advertisement applied for		
	5. Job interview invitation.pdfA written invitation from the employer including date, time, and place		
	6. IBAN.pdf Copy of Bank document showing you are the holder of the bank account with complete IBAN and BIC/SWIFT		
	can only be processed when all the requested documents have been sent and we written answers from the EURES Adviser and the employer.		
Can be sent later, latest one week after the job interview:			
	7. Travel documents.pdf Copy of travel documents (or bookings) connected to your travel to the job interview. For travel by car, keep receipts of your journey showing dates and locations of purchases
