

## Instructions for language course allowance application EURES Targeted Mobility Scheme (TMS) Sweden

Please note, you cannot start your language course until you have received authorisation from TMS Sweden.  
Processing can take up to four weeks, so please submit your complete application as soon as possible.

### To be sent at least 3 weeks before start of language course:

- ☐ **1. Language course allowance application.pdf**  
All requested information on the application form must be provided, including your signature (handwritten or e-signature) and the questionnaire
- ☐ **2. ID.pdf**  
Copy of passport or national identity card (both sides)
- ☐ **3. CV.pdf**  
Updated CV
- ☐ **4. Course offer.pdf**  
Detailed course offer from the language school: description of the course and indication of start date, duration, content/level and total cost are all mandatory.

The application can only be processed when all the requested documents have been sent and we have received written answers from the EURES Adviser and the employer/TMS staff.

If TMS Sweden authorises your language course, you will receive a **Payment Request** form with instructions on how to claim reimbursement of your actual costs, after completion of the course and presentation of documentary evidence: course certificate, invoice(s) and receipt(s).
